# You Can Do Much To Strengthen The Great Organisation that TNAI Is

There is a parable of a bird bringing water drop by drop in her beak, to quench the fire. The monkey sitting atop a tree mocks at the little bird saying, "What can you do to the wild, wide spread fire with the small act you are doing." The little bird replied, "When history shall be written, my name shall be mentioned in the list of those who contributed what one could, to for a noble cause". Like drop by drop ocean comes to existence, individual efforts go a long way to serve a purpose appearing that is really great. The point I am deriving is, each member of TNAI can help the organisation grow and strengthen. Of course that requires sincerity and commitment.

At TNAI, we continue to be concerned at the membership number vis-à-vis vast potential, as of around one lakh nurses pass outs every year, only 14000 to 15000 members are enrolled per year. This is something we have been fidgety about, for many years. In this context, our membership strengthening plan involved giving incentives to members based on their performance in two-year block. The new incentive plan seeks to reward members on monthly basis. We believe the new plan shall be perceived to be more attractive to motivate members for enrolling members in larger number. We request each member to spread the word, and begin by enrolling a minimum of one member; let the word be: Each One Enroll One. After all, in current era numbers matter and by numerical strength we shall be enabled to generate more funds to better serve the welfare of nurses and student nurses.

To ease and facilitate participation of final year nursing students in Basic Life Support (BLS) and Advanced Cardiac Life Support (ACLS), the institutions may note that the training in BLS/ACLS can be clubbed with TNAI Orientation visits. However, TNAI should be requested to this effect three weeks in advance so that necessary facilities can be arranged timely. It may also be noted that the charges for BLS are Rs. 2,500 inclusive of GST (this includes course fee, breakfast, lunch, dinner, tea, snacks,

# The XXVII (76th) TNAI Biennial National Conference 11-15 December 2018, Dona Paula, Goa: A Report

As scheduled, the XXVII (76th) TNAI Biennial National Conference was conducted at Dona Paula, Goa during 11-15 December 2018, befittingly.

TNAI Goa Branch, hosting the conference had made all necessary arrangements meticulously to the satisfaction of all. The initiative and enthusiasm of EC and Organising Committee Members made them take up the challenge of bringing the various nursing leaders representing entire nursing fraternity of Goa and elsewhere under one umbrella.

The immense support and guidance extended by Mrs Anita Deodhar, President TNAI, Dr S Sasankan, Vice President, West Region, Mrs Evelyn P Kannan, Secretary General TNAI and other office bearers have been remarkable throughout. Their advance visit and meeting boosted the state branch for making this grand event and enriched everyone in terms of true amalgamation of knowledge, skills and attitude.

A pre-conference meeting was organised on 10 December 2018 with the hosting branch executive and committee chairpersons of various committees along with the TNAI President and Secretaries. The chairperson of the committee updated about the development of the respective responsibilities.

The TNAI combined EC Council meeting started on 11 December 2018 at Institute of Nursing Education, Bambolim, Goa. Mrs Anita Deodhar, President, TNAI chaired the meeting. The state presidents, secretaries of TNAI state branches, co-opted, ex-officio members of TNAI (gathering of 65) were present in the meeting. Various ongoing activities and other issues of TNAI were discussed during this meeting.

EC Council meeting continued on the next day i.e. 12 December 2018; HOD meeting took place simultaneously; SNA General Committee meeting and ANM meeting took place at the same venue. The meeting was chaired by Mrs Anita Deodhar, President, TNAI. The other members present on the dais were Dr CN Bhargavi, Hony Treasurer, TNAI, Mrs Evelyn P Kannan, Secretary General TNAI, Mrs Vatchala S Dhinakaran, Asst Secretary General TNAI and Mrs Anuja K Sawant, State SNA Advisor, Mr Roseamio Fernandes, SNA Vice President, Mr Sahiel S Naik, SNA Secretary Goa State Branch TNAI. Various issues were brought for discussion by the representatives of SNA.

At the end of the day a cultural event was organised at Auditorium INE, Bambolim, where excellent performances were given by nursing staff from various institutions of Goa.

The House of Delegates (HOD) meeting was held on 13 December 2018; it started at 9.00 am. Mrs Evelyn P Kannan, Secretary General TNAI gave introduction about the role of HOD. After that Mrs OK Kathuria, Returning Officer, TNAI Elections 2018, gave a brief about the election process and the voting was started at 10:30 am. Four hundred six HODs from 29 states and union territories cast their vote and it ended at 4: 30 pm.

Simultaneously the inauguration of scientific posters took place at the hands of Mrs Rosemary Fernandes (former 3rd Vice President, TNAI). The posters were received and displayed; these were evaluated by expert members. These were adjudged by a panel of three eminent personalities of Nursing namely Dr Indira, Secretary, Andhra Pradesh State Branch, Sr Rosamma, President, Telangana State Branch, Mrs Surekha Sawant, President, Maharashtra State branch. The 1st prize, 2nd prize and 3rd prize were accorded to Brig Punita A Sharma, AFMC, Pune (Maharashtra); Lt Col Yamuna CB, AFMS, Pune (Maharashtra); Ms Chinju Raj, Jubilee Mission CON, Thrissur (Kerala) respectively during the Valedictory Session.

The counting of votes started at 5.00 pm and the result was declared at 9.00 pm. The newly elected Office Bearers were called onto the stage and the Election committee members congratulated them.

The Inaugural Ceremony of the conference was held on 14 December 2018 at Dr Shyama Prasad Mukherjee Stadium, Dona Paula (Goa). Post-lunch, the main activity of the business session was Purse Money. The delegates from all across the country gave their valuable contributions out of the hard earned money with zeal and enthusiasm.

The much awaited plenary session began at 2.30 pm. Three plenary sessions took place till 6 pm. In Plenary Session-I, with sub-theme **Nurse Practitioner: A Revolution for Global Nursing**, Dr K Reddemma, Nodal officer, National consortium for PhD Nursing delivered the key note address. This was followed by presentation on the theme by Prof Mrs Rajeswari Siva, Head, Community Health Nursing Dept, College of Nursing, CMC Vellore and Dr Phalakshi, Director Nursing, PD Hinduja Hospital, Mumbai.

Plenary Session-II was on the sub-theme **Global Standards for Nursing Education**. This session was moderated by Mrs OK Kathuria, former faculty at RAK CON, New Delhi. Dr Anice George, Dean, MCON, Manipal, Karnataka delivered the key note address followed by Mrs Usha Mallick (West Bengal) who presented her Scientific Paper on "A Study to determine the effect of mentoring on developing nursing competencies among the newly joined staff nurses in selected private hospital in Kolkata". It was followed by open discussion.

The plenary sessions helped the delegates and participants to invigorate and reconsider the issues of academic and professional interest, many of which they will surely incorporate in their daily practice. A total of 20 scientific papers were presented by the scholars and faculty members from different states of the country (Psychiatric Nursing - 4, Paediatric Nursing - 2, Obstetrics & Gynaecology Nursing - 4, Community Health Nursing - 3, Nursing Education - 9). It was attended by the delegates, who appreciated the efforts of the presenters.

After lunch, the delegates gathered for Valedictory function that began at 3 pm. At the start, the gathering was welcomed by Mrs Tanvi S Naik Chairperson, Programme Committee.
